### Fund objective

Abax Absolute Prescient Fund is a domestic fund with a mandate to invest across a wide range of local and foreign asset classes. The Fund has a maximum net equity exposure of 40% and a maximum net foreign exposure of 30% and 10% Africa (excl. South Africa). The Fund is suitable for retirement savings and it complies with Regulation 28.

The Fund's primary objective is to outperform Inflation + 3% p.a., over rolling 3 year periods (net of fees), without any negative 12-month periods.

The Fund has a low to moderate risk profile, and is suitable for investors seeking some capital growth and income without having to assume high levels of capital volatility.

### About the Fund

The Fund is actively managed and draws upon Abax's full skillset: asset allocation, valuation-based equity and fixed income security selection as well as our hedging capabilities.

The Fund is managed by Philip Liebenberg and Matthew de Wet.

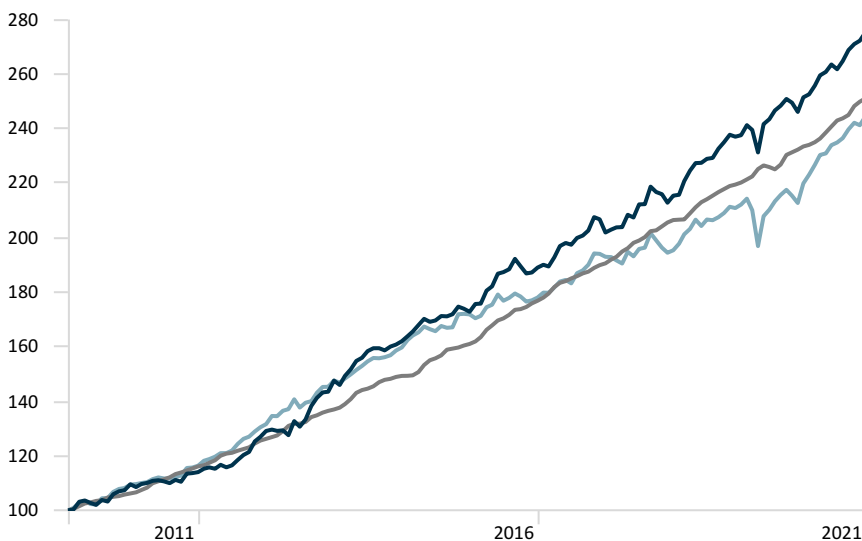

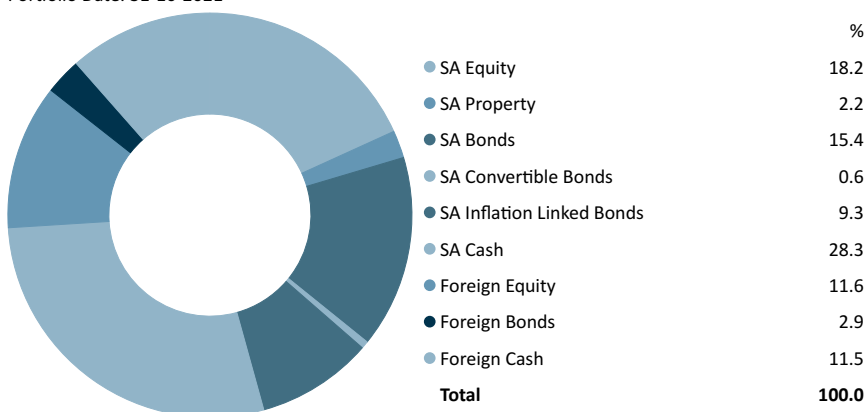

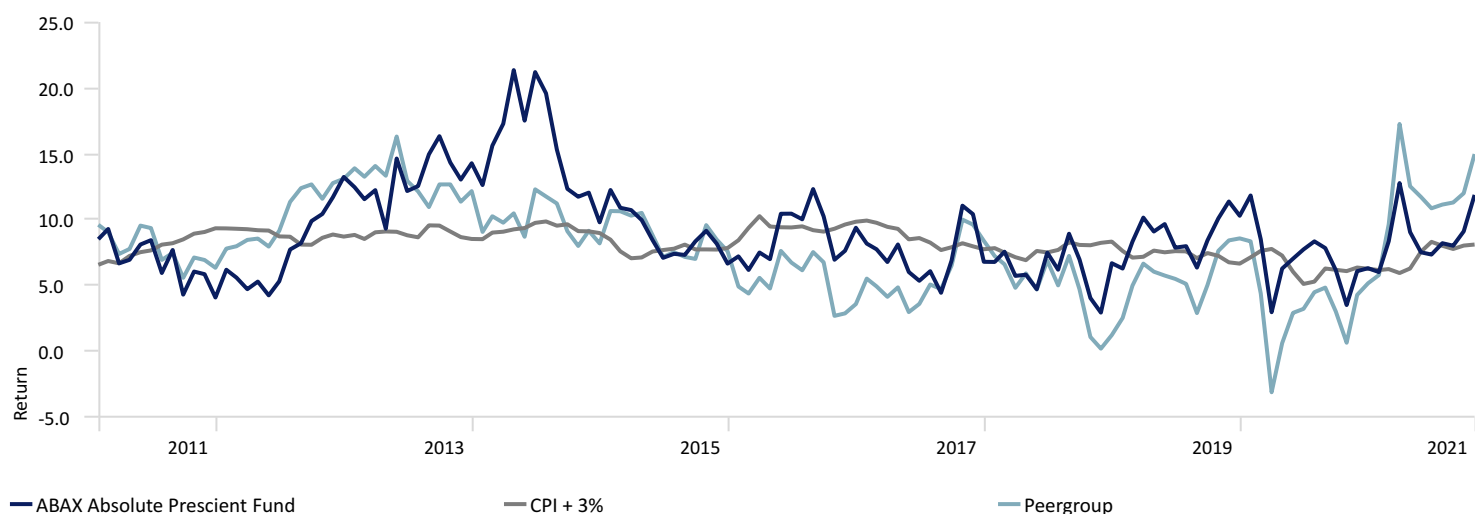

**Max Drawdown** - The maximum peak to trough loss suffered by the Fund since inception.
