# **Fund objective**

Abax Equity Prescient Fund is a domestic fund with a mandate to invest in listed South African equities.

The Fund's primary objective is to outperform the FTSE/JSE Capped Shareholder Weighted Index (Capped SWIX TR)\* over the medium to long term on a net of fees basis. A secondary objective is to outperform the peergroup (as measured by the ASISA General Equity Unit Trust Mean).

The Fund has a high risk profile, and is suitable for long term investors seeking high levels of investment growth, who can tolerate the associated high levels of capital volatility.

#### **About the Fund**

The Fund is actively managed and draws upon Abax's valuation-based security selection process.

The Fund is managed by Anthony Sedgwick, Marius van Rooyen, Omri Thomas and Steve Minnaar.


